

# **Highlights for 2014**

- A Net Income (Surplus before Grants) of \$55,000 was raised this is a fantastic result, surpassing the previous record of \$35,000 set in 2012. This was mostly due to having a successful Fiesta and Chocolate fundraiser in the same year.
- Other Key fundraising events for the year were Touch Rugby (biggest year yet), Calendars, Disco, Entertainment Books, as well as the BBQ see Page 6 for details.
- A high level of Equity (\$46,000) and Funds on Hand (both \$49,000).
- Grants (a record level) of \$44,000 were made to the school for Garden to Table, Sunshades, Year Books, School Syndicate resources, continued Hall upgrade, I-pads, TV Data Projectors, Library shelving, as well as art aprons, and kapahaka clothing.

#### Note 1 Accounting Policies

- The entity is a society incorporated under the Incorporated Societies Act 1908. These Financial Statements have been prepared in accordance with generally accepted accounting practices.
- The measurement base adopted is historical cost. Accrual accounting is used to recognise expenses and revenues when they occur.
- Accounts Receivable are stated at their estimated net realisable value.
- Goods and Services Tax (GST) This Society is not registered for GST.
- **Differential Reporting** This Society is not publicly accountable and is not considered large as defined under the framework for differential reporting. The Society has taken advantage of all differential concessions available to it.
- Changes in Accounting Policies There have been no changes in accounting policies. All policies have been applied on bases consistent with those used in previous years.
- Contingent Liabilities There are no contingent liabilities at year end (Last Year \$Nil)
